

Storyteller Portraits TF* Agreement

1. INTENT: This shoot is conducted as 'work in trade' in the spirit that all parties are considered as contributing equal work and receiving equal benefits - the value of the likeness release being equal to the value of the image license, as stated in the work product section below.

2. WORK PRODUCT: a.) Model furnishes a release as set forth in Section 4 below. b.) Photographer furnishes image license as set forth in Section 5 below. c.) Within 2 weeks, Photographer agrees to provide model a representative sampling of all 'looks' shot, available digitally as 1800 pixels on the longest side, watermarked with "www.StorytellerPortraits.com ." (Higher resolution and/or retouched images will only be provided to models who have returned this signed release.)

3. RECIPROCAL CREDIT: Model and Storyteller Portraits agrees to always credit each other where ever the image is used for self promotion. (Indirect means such as titles, footnotes, endnotes, or a credit box which appears while hovering on image are acceptable.)

4. MODEL'S LIKENESS RELEASE TO PHOTOGRAPHER: In consideration of my engagement as a model, and for other good and valuable consideration herein acknowledged as adequate and received, I hereby grant the following rights and permissions to Brian Street, aka Storyteller Portraits, his/her heirs, legal representatives, and assigns, those for whom Photographer is acting, and those acting with his/her authority and permission. They have the irrevocable, perpetual and unrestricted right and permission to take, use, re-use, publish, and republish photographic portraits or pictures of me or in which I may be included, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium at his/her studios or elsewhere, and in any and all media now or hereafter known, specifically including but not limited to print media and distribution over the Internet for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever. I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, perspective, context, foreground or background. I also consent to the use of any published matter in conjunction with such photographs. I hereby waive any right that I may have to inspect or approve the finished product or products and the advertising copy or other matter that may be used in connection with them or the use to which they may be applied. I hereby release, discharge, and agree to hold harmless Photographer, his heirs, legal representatives, and assigns, and all persons acting under his permission or authority or those for whom he/she is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of such photographs or in any subsequent processing of them, as well as any publication of them, including without limitation any claims for libel or violation of any right of publicity or privacy. I hereby warrant that I am of full age and have the right to contract in my own name. I have read the above authorization, release, and agreement, prior to its execution, and I am fully familiar with the contents of this document. This document shall be binding upon me and my heirs, legal representatives, and assigns.

5. PHOTOGRAPHER'S IMAGE LICENSE TO MODEL: While copyrights remain with Storyteller Portraits, with all rights reserved, Storyteller Portraits hereby grants unlimited license of properly credited images to model for self-promotion. Additionally, Storyteller Portraits grants permission to model for further retouching or cropping provided that credit is given similarly to "Original photography by Storyteller Portraits, with further manipulation by __ (insert name) __."
